- III. Class 10th & 12th Mark sheet and Certificates.
- IV. Mark sheet of Diploma/ Degree.
- V. Diploma/ Degree (Recognized by AICTE/UGC/University/Statutory State Board/Indian Medical council or equivalent recognized under the relevant council).
- VI. Valid Caste certificate if applied under SC/ST/OBC/EWS category issued by the competent authority.
- VII. 'No Objection Certificate' if in regular employment in Government/Semi Government/PSU Institution.
- VIII. Experience Certificate, if any (With Supporting evidence viz. PF/ESI/Account. Statement/Salary slip along with experience certificate).
- IX. Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Card and Government Approved Identity Proof)
- X. Address Proof (Aadhar Card, Passport, Ration Card, Driving License and Government Approved Address Proof)
- XI. Any other relevant documents.
- XII. All candidates are to bring an Affidavit on Non-Judicial Stamp paper of denomination of Rs.50/- as per "**Proforma-A**" attached.

**Important Note:-**

- Age and all other qualification will be counted as on the last date of submission of application.
- The period of experience wherever prescribed shall only be consider after obtaining the prescribed qualification.
- Interview call letters will be sent by email to all the eligible candidates. Candidates are required to report in Medical College Block, AIIMS Jodhpur at their respective reporting time
- Applicants will be informed by email/ Website Notifications. No hard copies will be dispatched. The Institute is not responsible for any delay in receipt of information etc. Applicant should keep visiting our website & check registered email and report at the time as mentioned in the schedule for document verification and interview.
- Those candidates who receive interview letters, should carry printouts of same.

  - Service/Innovations (One Slide)
  - Research/Publications (One Slide)
  - Major Recognition/Awards (One Slide)
