NOTICE FOR INFORMATION OF THE CANDIDATES FOR FACULTY POSTS

Reference advertisement no. Admn/Faculty/01/2024-AIIMS.JDH dated 11.03.2024 with subsequent corrigendum dated 15.04.2024 issued for recruitment of various faculty posts on regular basis for AIIMS, Jodhpur.

The applications alongwith documents of those candidates who have applied within prescribed time were placed before the Scrutiny Committee of the Institute for ascertaining their eligibility for the posts as per the prescribed Recruitment Rules for the concerned post. The Scrutiny Committee has adjudged the candidates as Eligible, Provisionally Eligible and Not Eligible as per Annexure – 1.

The Candidates who have been adjudged as Eligible and Provisionally Eligible as per **Annexure – 1** are hereby informed that the interview for these posts will be held in near future and date & time for interview will be uploaded on the Intuitional Website. Those candidates whose eligibility has been decided as “Provisionally Eligible” are to submit the necessary documents/clarification as mentioned against their names on or before the date of interview. Only those candidates who will submit such clarification/documents will only be allowed for interview.

Those candidates who have been adjudged as “**Not Eligible**” may also write to the Recruitment Cell for any genuine query supported with documents and submit their representation to the Recruitment Cell email (fr.aiimsjodhpur@gmail.com) alongwith copy/ scanned copy of all supporting documents on or before **09.07.2024**. No representation received thereafter (**09.07.2024**) would be entertained and no further correspondence will be entertained in this regard.

It is, further, clarified that the scrutiny of application at this stage has been done solely on the basis of entries filled by the candidates in the application form and the documents submitted alongwith his/her application form for which the final verification of the original documents/testimonials will be done before the interview by a Committee constituted for this purpose. It is intimated that eligibility of all the candidates at this stage is provisional and merely that

candidate has been adjudged as 'Eligible' at this stage does not confer any right of his/her being selected for the post. If at any time during the selection process, it comes to the notice that a candidate has filled wrong entries/does not have the required qualification as per the Recruitment Rules of the posts, he/she will be treated/declared as 'Not Eligible' and his/her candidature will be treated as cancelled.

The list published on the website is for information only. Candidates are advised to verify their eligibility status with official documents or communication from the AIIMS, Jodhpur.
